CEO's Report

It is with great pleasure that we announce the 2019 VICSWIM Summer Kidz program a resounding success.

After the Victorian State Government announced, in May 2018, it would provide \$1.2 million of funding for the VICSWIM program over next three years, Victorian families have shown their support with VICSWIM registrations increasing from 10,649 enrolments in 2018 to 13,864 in 2019

An incredible increase of 30% in enrolments from last year's VICSWIM program.

The VICSWIM Summer Kidz program, has been running since 1976, is an intensive learn to swim program held over three weeks in January each year. Each VICSWIM enrolment costs \$30 and provides participants with 5 x 30 minute lessons delivered across 5 consecutive days, developing each child's water safety awareness, respect for different water environments, swimming skills and survival skills.

Families have the option of enrolling their children in multiple programs over the three weeks the program runs.

This year the VICSWIM Summer Kidz program delivered over 34,660 hours of swimming lessons to children aged between 4 and above in just 3 weeks. Bringing communities together for education, fun and a sense of social inclusion. An astonishing figure!!

The 2019 VICSWIM program created several milestone achievements, including:

- attracted 13,864 enrolments, an increase of 30% in enrolments from 2018 and an increase of 58% since 2014
- Was conducted at 170 venues (23% increase from 2018)
- Was run in 60 of the 79 Victorian municipalities (16% increase from 2018) plus two venues in Albury NSW
- VICSWIM was delivered by over 365 swim teachers of which VICSWIM employed 280 of them with the balance being provided by host venues.

 Administered and supported by 22 regional co-ordinators and up to 10 customer service staff

The Victorian Government invests in the future of VICSWIM

The VICSWIM program was established in 1976 and we are incredibly proud that the program remains as relevant and as vital in the Victorian Government's water safety strategy today as it was a generation ago. The three-year funding commitment by the Victorian government has allowed Aquatics and Recreation Victoria (ARV) to confidently invest in redeveloping the VICSWIM program. From the resources, training and support we provide to our swim teachers and staff, the registration and information website used by families through to our back end administration platform.

The evolution and success of VICSWIM remains vital in our nations fight to reduce drowning deaths to zero. We do this by providing our aquatic service to those who would not normally have access, given a variety of barriers including location, access or financial constraints. Supporting rural and regional community liveability is important to VICSWIM and the inclusion of the VICSWIM program provides a mechanism to access programs often not provided beyond the metro areas.

In the 2017/2018 financial year, 249 people drowned in Australian waterways with 40 of those drowning in Victoria. Of the 40 Victorian drowning fatalities, 23 occurred during the summer months between the 1st of December and the 28th of February.

At a time when drowning deaths remain unacceptably high in Victoria, the value of the 2019 VICSWIM program should not only be measured in the number of participants or the more than 34,660 hours of swimming lessons delivered by the program, but equally important is the program's ability to raise the awareness of swim safety and survival to the participants friends and families during the high risk summer holiday period, a time when the risk is at its potential peak.

VICSWIM is loved by parents

The quality of the 2019 VICSWIM program is not simply around the raw participation figures but the amazing satisfaction ratings the program has received from parents, venues and teachers in our post program surveys.

In the post program survey sent to all parents, the 2019 VICSWIM program scored an incredibly high 71.47% Net Promoter Score rating with parents giving the program a satisfaction rating of 8.6 out of 10 .

An amazing 40% of responding parents also indicated the VICSWIM program was the only swimming lessons their children had participated in during the last 12 months. This means, if it was not for the VICSWIM program over 40% of participants would not have had swimming lessons in the last 12 months. For those in many rural and regional locations, VICSWIM provides a swimming opportunity which would simply not exist otherwise, further contributing to the quality, liveability and safety of those communities.

To re-enforce the public demand for VICSWIM, 90% of parents surveyed indicated they were highly likely or likely to enrol their children in the 2020 program and 97% believed there was scope to grow the program in their community if additional programs were made available.

In more locations than ever before

Growing the accessibility of VICSWIM for all Victorians is a key goal of the program so I am very proud to report that of the 170 venues that hosted VICSWIM in 2019, 126 (74%) of them were located in rural or regional Victoria.

Not only was the VICSWIM program delivered at 170 venues around Victoria, the diversity of locations provided very different swimming experiences. In 2019 the VICSWIM program was run at:

- 29 Metropolitan indoor venues
- 16 Metropolitan outdoor venues
- 17 Regional indoor venues
- 93 Regional outdoor venues

- 2 Inland open waterway locations
- 13 Open water beach locations

Providing swimming and survival lessons at the beach, in a controlled and safe environment, ensures the program is incredibly relevant to the swimming behaviours of Victorians. Each year it is the beach based open water swim locations which attract the greatest number of participants along with the highest satisfaction rating of parents.

Local Councils ensuring VICSWIM is accessible to all Victorians

The success of the VICSWIM program simply would not be possible without the support of Local Councils and providers around Victoria. In 2019, VICSWIM was delivered in 60 of Victoria's 79 municipalities. Each of the 60 participating councils ensured that the VICSWIM program could run without any venue hire charges, providing additional staff such as life guards or customer service staff and on some occasions opening their pools outside normal operating hours.

Increasingly, many councils are appointing professional contract management groups to run their pools and support from these facility managers has been outstanding. Not only did they generously provide pool space for the program but many provided the swim teachers, significantly easing the burden of sourcing teachers on the VICSWIM administration team.

It is a primary focus of VICSWIM to ensure the families most in need are able to access affordable swimming lessons. In 2019 VICSWIM was run in 15 of the top 20 municipalities with the greatest disadvantage. Pleasingly, in these 15 municipalities VICSWIM was offered in 38 different locations.

While continuing to grow the number of venues hosting VICSWIM is important to ensure program accessibility in 2020 and beyond, we will continue to engage those Top 20 municipalities with the greatest disadvantage that currently do not host a VICSWIM program. That is, Central Goldfields Shire, Northern Grampians Shire, Ararat Rural City, Benalla Rural City and Campaspe Shire.

Our amazing swim teachers

It is a mighty feat to recruit and train over 365 swim teachers who are willing to work for up to three weeks, often during what is arguably the most popular time of the year to take leave. It would be impossible to deliver 34,660 hours of swimming lessons in three short weeks without our amazing swim teachers and it is our swim teachers who create such immense satisfaction ratings reflected in the post program surveys.

It is no surprise that the programs that rate highest in the parent survey results are linked directly to the quality of our swim teachers at each program. This confirms our intent to continue to invest in training and development of our swim teachers across the state.

In many regional communities it has become clear that they simply didn't have enough, and in some cases any, qualified swim teachers. To cover the teacher shortfall, many teachers either travelled large distances to deliver the program, stay at their locations for the duration of the program or taught for many more hours than they would have preferred. To these wonderful teachers I am extremely grateful for your commitment, understanding and willingness to support the program in such a selfless manner.

VICSWIM is recruiting and training swim teachers for the industry

Our passionate swim teachers are our programs greatest asset, but sourcing enough teachers is also our greatest challenge. This has been especially challenging in rural and regional areas.

The Victorian governments three-year funding commitment to VICSWIM has allowed ARV to partner with industry stakeholders to start to address this state wide and moreover, an industry wide issue.

In July 2018, VICSWIM established targeted swim teacher courses in which we provided full scholarships to budding swim teachers in regional areas of Victoria. Initially around the Wodonga/Albury region, VICSWIM intends on delivering

this type of industry support right across the state.

To encourage participation in these courses, ARV funded 50 swim teacher scholarships. The scholarships are designed to attract first-time swim teachers, locally-based and currently working within the community or looking to enter the aquatic and leisure industry.

The short-term outcome of this highly successful teacher recruitment strategy was, that for the first time in many years, VICSWIM was run at 4 venues across the twin cities of Wodonga and Albury, attracting 260 enrolments. Longer term though, the recruitment and training of swim teachers will have ongoing benefits for the region.

In 2019 and beyond, ARV will seek to join with other industry partners and regions with a view of growing the scholarship program in rural and regional areas that are in the most need of attracting swim teachers to their communities.

Keeping the low participation cost of VICSWIM is vital for families

Keeping the VICSWIM program costs as low as possible is vital to ensure children from families from lower socio-economic backgrounds have access to swimming and water safety lessons.

With the support of the Victorian Governments three-year funding commitment, ARV has been able to run the VICSWIM program for a significantly reduced price compared to the learn to swim industry for the 3rd successive year at \$30 per week of swim lessons.

One financial barrier inhibiting participation is that some venues charge venue entrance fees to participants and in some instances for the non-swimming guardians also. This year, entrance fees ranged between \$0 - \$6 per VICSWIM participant, per day. For many parents, especially those with multiple children, the additional venue entry costs made the VICSWIM program unaffordable.

Key partners including private swim schools, local governments and leisure management companies recognised this affordability was a major issue for many families so as part of their support to increase the number of children who have access to swimming lessons around Victoria, they ran the program with free pool entry. In YMCA Victoria's case, free entry was also provided for the entire family of VICSWIM participants enrolled in the program.

In the 2019 VICSWIM program 91 of our 170 venues (53%) did not charge an entrance fee. To these venues we greatly appreciate your support to make VICSWIM truly accessible to Victorian families. We will continue to work closely with our venue partners in the lead up to the VICSWIM 2020 program to minimise where possible the venue entrance costs for families.

VICSWIM participants are registering into regular swimming lessons

As mentioned earlier, the post program surveying of parents identified that for 40% of participants, the VICSWIM program was the only swimming lessons those children participated during the last twelve months. While this shows the value of VICSWIM for these children, participating in only VICSWIM each year will not adequately teach these children to swim at a safe level unsupervised.

The post program survey has identified that one of the benefits of the VICSWIM program is to highlight to parents the importance of regular swimming lessons. Although swimming lessons are offered as part of many school curriculums, often parents are genuinely surprised at their child's lack of competency in the water, especially at open water venues. The VICSWIM program re-enforces the need for parents to ensure their children, where possible, participate in regular swimming lessons to develop their swimming and water safety skills.

A number of venues have introduced a variety of strategies to encourage VICSWIM participants to enrol into their ongoing learn to swim programs. ARV will work with these venues to identify "conversion" rates and understand how the transition rate of VICSWIM

participants into regular learn to swim programs can be maximised into the future.

With the requirement of all Victorian Government and Catholic primary schools needing to provide swimming and water safety programs as part of Health and Physical Education within the Victorian Curriculum F-10, there is significant pressure on schools in supporting children to achieving a level of competency equivalent to the Victorian Water Safety Certificate before graduating.

VICSWIM goes a long way in supporting this objective however there is a significant amount of work left to be done to bring the competency standard of Victorian children to an acceptable level. The Victorian Water Safety Certificate focus' on four key areas of competency to demonstrate. These areas are, water safety knowledge, rescue skills, a survival sequence and being able to swim 50m continuously. VICSWIM gives us a great insight into children's capabilities from right across the state. Taking all VICSWIM participants aged 11 and above, we know that 40% of them are enrolled in the program at level D or below. This means they are unable to achieve a level of competency equal to that of the Victorian Water Safety Certificate. With much more work to be done, this only further highlights the significance of programs such as VICSWIM in supporting the Victorian Department of Education and Primary Schools across the state in aquatic education.

Healthy Swimmer Kits

Aquatics and Recreation Victoria was pleased to support the Victorian Governments, Department of Health and Human Services "Healthy Swimmer" initiative throughout the 2019 VICSWIM program. This initiative educates children and families about healthy swimming behaviours in young swimmers.

Many VICSWIM participants were given a "Healthy Swimming Kit" which consisted of a draw string bag, water bottle, hand sanitiser and promotional materials delivering these very important messages. Feedback from parents was the "Healthy Swimming Kits" were very well received by the children.

Investing in the future

Participation is one single metric when developing the water safety and skill level of Victorian children. The three-year investment provides an opportunity to assess and develop capacity measures to ensure children are best placed to achieve the competencies of the Victorian Water Safety Certificate by the appropriate age.

Over recent years we have built a foundation that will ensure that the VICSWIM program will grow exponentially over the next five years. Growth, not just in the number of children participating in VICSWIM, but in the number of venues hosting VICSWIM, the diversity of these locations, the number of swim teachers delivering the lessons and the number of administrative support staff to handle the families requiring customer service assistance.

I have made mention a number of times throughout this report of the importance of the Victorian Government committing funding to VICSWIM for three years. Primarily, this funding allows ARV to invest funds immediately into the VICSWIM program to ensure the program can grow without detrimentally impacting quality or participant safety or satisfaction.

Empowering our swim teachers will ensure participant safety

Ensuring nearly 14,000 participants remain safe for every second of the 34,660 hours the program is delivered is unquestionably the greatest obligation of the VICSWIM program.

Over recent years we have found that over 50% of our swim teachers participating in the VICSWIM program each year were teaching the program for first time. Whilst each swim teacher is suitably qualified, it is vital that we continue to develop our induction and training environment to provide swim teachers with all the knowledge, resources, processes and procedures required to deliver not only great swim lessons but safe environments at all times.

This is a particularly important, as we increase the number of outdoor and open water venues into the future. We continue to develop our training resources to aid the transition of pool based swim teachers to be able to confidently and successfully teach in variety of very different outdoor venues.

In the post program survey to teachers there was overwhelming support for the increase of information and resources

which would empower teachers to increase not only the quality of the swimming lessons but also the safety of participants.

ARV will continue to invest in the development of resources and training programs that will equip our swim teachers for the unique experience of teaching the VICSWIM program. These skills will also assist the teachers as they return after the summer period to teach through the year in their respective workplaces.

Investing in Regional Co-ordinators

Another significant enhancement to the 2019 VICSWIM program, was the expansion of our team of Regional Coordinators. Regional Co-ordinators are the primary point of contact for their allocated venues and swim teachers. They ensure each venue is safe to conduct the program and are responsible for the teacher induction and training for the VICSWIM program. 2019 saw an increase in the number of Regional Coordinators employed with 22 supporting head office implement the VICSWIM program. This was an increase from 14 the previous year.

I am extremely proud of the value that VICSWIM creates for Victorian families through our huge team of swim teachers, regional co-ordinators, participating venues and the tireless efforts of our VICSWIM customer service team.

Our investment in technology will continue

One of the significant factors keeping the VICSWIM cost so low for the participating families is a significant investment in technology over the last two years. The secured funding will support the continued technology development to ensure we are operating in the most effective and efficient way.

We will continue to develop our online booking functionality, developing the VICSWIM website to make it even easier for parents to use. We will also redevelop our venue and teacher management systems to ensure these platforms can cope with the expected growth as well as improve the functionality offer to these very important groups.

Opportunities to grow

The VICSWIM program has huge potential to grow both the number of participants and the number of venues and communities in which the program is offered. The introduction of administration technology will allow us to increase participation in future VICSWIM programs simply by giving us the ability to easily identify occupancy opportunities and use targeted marketing to fill vacancies. It will allow better programming and greater

efficiency as well as providing further opportunity for data analysis and evidence-based decision making.

A long identified, area of potential growth for the program is to attract more participants from a multicultural or aboriginal background. The post program survey identified that 78% of participants parents were born in Australia, 83% only spoke English at home and 93% of parents were Australian citizens. Less than 1% of parents identified themselves as of Aboriginal or Torres Strait Islander heritage.

In Victoria, 35% of drowning deaths in 2017/2018, where people from CALD communities (Culturally and Linguistically Diverse). Participants from CALD communities have long been identified as having very low participation in the VICSWIM Summer Kidz program. It is now very clear that specific marketing, partnerships, relationships and funding will be required if this very important and at-risk part of our community are to be introduced to the benefits of the broader VICSWIM program.

In closing, I would like to publicly thank everybody who has contributed in making VICSWIM possible.

From the commitment shown by our wonderful VICSWIM teachers and regional coordinators, partnering venues and operators. To the passionate support of Victoria's local councils, municipalities and aquatic facility managers who have so positively embraced the program. To the amazing customer service of the VICSWIM Administration team including the invaluable Sports Community team who, for the second year in a row, have provided such wonderful administration support and commitment to the program.

Again, I would like to thank the Victorian State Government for having the vision and foresight to continue to invest in the children of Victoria through the VICSWIM program.

Finally, I would like to thank the ARV Board for their unwavering support of the VICSWIM program and our team who make it possible. Your support has been unmeasurable through this exciting period of program development and growth.



2019 VICSWIM Statistics

Program Participation

Figure 1.1 and 1.2 below illustrate that participation in the VICSWIM Program has grown 30% since the 2018 Summer Kidz Program, and 59% in 5 years.


With Continued investment in marketing, technology, recruitment, development and retention its anticipated the programs strong growth will continue in the short term.

Participation by week and skill level

Figure 2.1 and 2.2 illustrate the spread of skill level and enrolments across the three weeks.

Week 1, (37% of enrolments) and Week 2 (38% of enrolments) were the programs busiest weeks. Week 3 only had 25% of enrolments but the major factor in this reduction was that those venues who ran their own learn to swim programs were unavailable due to their own programs commencing.

Figures 2.2 and 2.3 shows that once again, lower levels (A, B and C) were the most popular, with 67% of participation falling into these levels. Level D accounted for 15% of enrolments. The higher levels, (E, F and G) accounted for only 18% of enrolments collectively.




Participants age profile

As Figure 3.1 illustrates below, the ages of VICSWIM participants ranged from 4 years of age and above with 77% of participants born between the years of 2009 and 2014.

Age v Competency

Competency level D and below are children who are enrolling in a VICSWIM level below the equivalent overall competency levels stated on the Victorian Water Safety Certificate (VWSC). Figure 3.1 indicates that of all children participating in VICSWIM only 21% have achieved a level of skill equivalent to the VWSC when enrolling. When considering children in their senior years of primary school (aged 11+), figure 3.1 show that 40% of these children have not reached the equivalent levels of the VWSC. It is important to note that these children are actively participating in extra curricular swimming through the VICSWIM program and these figures are not representative of the overall general performance of school aged children.

Venues and participation

Figure 4.1 lists the number of enrolments at each venue, whether or not they charged an entry-fee or similar to participating families, if they were new since 2018 and whether or not they self-staffed.

The five venues with the largest number of enrolments were:

- 2. Torquay Cosy Corner (Regional, Open water) 568
- 3. Ivanhoe Aquatic Centre (Metropolitan, Indoor) 529
- 4. Bendigo East Swimming Pool (Regional, Outdoor) 316
- 5. YMCA Knox Leisureworks (Metropolitan, Indoor) 268





Participating local councils

There are 79 municipalities in the State of Victoria, of which 31 are metropolitan and 48 rural or regionally located. In 2019, 60 (76%) of the 79 municipalities hosted VICSWIM. This is 10 municipalities more municipalities hosting VICSWIM than the 2018 program, an increase of 14.4%. In 2019 VICSWIM was also hosted by Albury City Council as part of twin cities approach for the Albury/Wodonga region. This brings the total number of municipalities to 61.

Figure 5.1, identifies the Victorian municipalities and the number of venues in each that hosted a VICSWIM program in 2019.




Programs per Regional Municipality

Index of Relative Socio-economic Advantage and Disadvantage

The Australian Bureau of Statistics calculates a rating system titled the "Index of relative Socio-economic advantage and Disadvantage" (IRSAD). This rating system "summarises information about the economic and social conditions of people and households within an area, including both relative advantage and disadvantage measures. A low score indicates relatively greater disadvantage and a lack of advantage in general and a high score indicates a relative lack of disadvantage and greater advantage in general."

Participating municipalities

When the IRSAD ranking is added to the list of participating municipalities (Figure 6.1 and Figure 6.2), 15 of the top 20 municipalities with the greatest disadvantage hosted at least one VICSWIM program. It is important that the VICSWIM program continue to expand into the municipalities with the lowest IRSAD to ensure that the program achieves its core objective of ensuring affordable swimming lessons are accessible to those who may not otherwise be able to afford them.

Municipalities not currently hosting VICSWIM programs

When the IRSAD ranking is added to the list of non-participating municipalities, it was identified that 5 of the top 20 municipalities with the greatest disadvantage did not host a VICSWIM program. Of the 19 municipalities not hosting the VICSWIM program in 2019, 3 ranked in the top 10 municipalities with the least social and economic disadvantage, that is Victoria's most affluent municipalities.

While it is vitally important that the VICSWIM program is accessible to all Victorian children, we will continue your focus of maximising access to VICSWIM in regions it is most needed.

VICSWIM marketing and promotions

Reflecting upon 2018, it was decided that a strong, consistent digital marketing strategy was necessary to support the 2019 VICSWIM Program.

Rather than focus on radio and TV marketing as we had done in previous years, the 2019 marketing strategy was predominately driven using social media and email communications to previous participants.

This was supported by posters and flyers being distributed to participating venues and a number of schools and kindergartens.


VICSWIM extended their digital marketing strategy to also incorporate the social media of participating venues, and encouraged swim teachers and parents to share posts and information on their own personal channels.


We also joined the Facebook groups of many local communities and posted information directly to their communities.

To encourage venues to promote VICSWIM on their social media channels we created and social media posts and digital collateral specifically for their use. This strategy saw a significant increase of traffic to the VICSWIM Facebook page and ultimately into enrolments.

The digital marketing strategy begun in September, in the lead up to the opening of bookings on October 22, 2018. This campaign element of the strategy saw 5,171 enrolments in the first 24 hours of bookings being open.
