



CEO's Report

Despite the challenges and the uncertainty of both planning and delivering VICSWIM in a COVID-19 affected Victoria, I am proud to report that the 2021 VICSWIM Summer Kidz Program was again a resounding success. Conducted in the three weeks between January 4th - 22nd, the program attracted an amazing 16,516 enrolments - 556 more than 2020. We processed 375 refunds due to COVID implications, border closures and medical conditions. Over 300 swim teachers at 167 venues delivered 3,362 classes meaning that 80,705 swimming lessons totalling an accumulated total of 40,353 hours of swimming lessons were delivered.

The success of VICSWIM 2021 program should not be measured by the numbers alone, but also by the program's ability to increase the ability and awareness of water safety and survival skills of each participant, their family and more broadly their friends during the summer holidays. A time made even more important this year with the closure of the aquatics industry meaning so few Victorian children able to participate in formal swimming lessons throughout 2020.

The challenges of a COVID year

At the end of last year's VICSWIM program, it was thought that conducting a Victorian VICSWIM program could not get more challenging. The astounding complexity of running the program in a state seriously affected by bush fires, extensive smoke haze, large storms, water pollution, dust storms and air pollution, along with the normal challenges of running the program at 186 venues across the whole of Victoria was expected not to be repeated.

How quickly our perspective changed, when in March 2020 Victoria started to shut down in response to the community threat posed by the Coronavirus pandemic and like every other Victorian community event, the 2021 VICSWIM program was immediately thrown into uncertainty. The most obvious question, 'would we even be able to run VICSWIM 2021?' remained relevant for much of the year, after which further questions regarding the viability of the program emerged.

A number of these were not able to be answered for the majority of the planning cycle. These included:

- Under what community safety conditions could VICSWIM 2021 operate?
- Would there be any restrictions placed on venues or group sizes?
- Would venues want to participate?
 Would they even be able to participate?
- Would swim teachers want to again participate in the program?

Most importantly, did parents and the community want VICSWIM 2021 to proceed and if it did, would they have the confidence to participate?

With so much uncertainty, the normal VICSWIM planning cycles were delayed significantly while awaiting guidance from the state government as to conditions under which VICSWIM 2021 may or may not operate. I would like to acknowledge the outstanding support received from the Victorian Government as they sought to guide Victoria into a COVID normal environment. Their willingness to collaborate and communicate throughout the year was a key determinant in the success of this year's program.

Huge participation and community Support

VICSWIM registrations, under normal circumstances would open early October but this year, when registrations opened much later on November 23rd, we were very unsure the level of community support for the program.

This question was answered immediately with the sheer volume of enrolments to the VICSWIM website crashing the registration system for the first 30 minutes until our IT company were able to rectify the issue and enable it to handle the increased traffic.

By the end of the first day of registrations opening, there were over 8,880 registrations, growing to over 10,000 registrations in the first 24 hours. To put this in perspective the entire VICSWIM program in 2017 only had 10,424 registrations.

By the end of the program there were 16,516 enrolments into VICSWIM 2021, a slight increase on the 16,116 enrolments of last year's program. An outstanding outcome, given the reduced capacity of this year's program and the fact that 375 enrolments were refunded due to Coronavirus quarantine restrictions, testing and the provision of medical certificates. After all eligible refunds were processed, there were a total of 16,141 enrolments.

Venue participation

With most aquatic venues forced to close down for much of 2020, there was much uncertainty about how venues would respond when invited to again participate in this year's program. We were overwhelmed by the support received from local governments and venues managers with 167 venues joining the program.

While this is a decrease of 19 from the 186 venues who participated in 2020, it is still a great result especially as many of the non-returning venues, chose to (or were financially forced to) run their own programs to generate much needed revenue. Many Gippsland venues determined not to participate in the VICSWIM 2021 as they continued their recovery from last year's devastating bush fires.

This reduced number of venues meant that the program's maximum capacity decreased from 19,988 places being offered in 2020 to 18,712 places being offered in 2021. Many venues offered significantly reduced lane space, shorter availability of lanes or reducing the number of weeks they participated in the program.

Involving 16,141 enrolments in VICSWIM 2021 was an outstanding outcome given the maximum capacity of program decreased from 99,940 lessons in 2020 to 93,560 lessons in 2021. As a result, the occupancy of the program increased from 77.93% in 2020 to a staggering 86.26% in 2021.

Recruiting our amazing swim teachers

Traditionally, one of the most challenging aspects of running a VICSWIM program is

to recruit the 300+ swim teachers required to run the VICSWIM program. This year became even more challenging with a large number of swim teachers leaving the learn to swim industry to find alternative employment throughout the COVID 19 shut down period or being seconded to other industries or required to fulfil or be engaged by their own employers to run summer holiday programs.

Many swim teachers benefited from the federal governments job keeper allowance with the unintended consequence being that many swim teachers chose not to supplement their incomes with a swim teacher job like they normally would.

This has been an industry wide challenge experienced by many venue operators across Victoria.

Recruiting teachers was made slightly easier by the tremendous support offered by the learn to swim industry and particularly to the 14 venues who "self-staffed".

Retaining our amazing swim teachers

Of our 300+ swim teachers, 43% were new to the program this year. A vital VICSWIM future strategy is to create a swim teacher recognition and reward strategy that acknowledges the amazing contributions of so many of our swim teachers. I acknowledge, for example, teachers such as Robbie Rae, Wilfred Dickeson or Regional Co-ordinator Jillian Cooper who have been an inspiration to so many for over 20 years. This strategy will become the foundation to the VICSWIM swim teacher recruitment strategy by maximising the number of teachers who wish to return year on year.

While the VICSWIM program ensures high quality logistics and customer service, it is the dedication and passion of our swim teachers which drives our incredibly high satisfaction ratings.

VICSWIM is loved by Victorian families and their communities

For many Victorian communities and families, VICSWIM is an event in their year which is looked forward to throughout

the year, not just by the children but by parents, grandparents, families, friends, community Aquatics and Recreation facilities and other community members who use the program to strengthen connections within their families and their local communities. With the social disconnections felt throughout 2020, this year's VICSWIM program was more important to these communities and families than ever, as is evident in the enrolment numbers.

VICSWIM registrations have grown from 9,270 registration in 2016 to 16,516 registrations in the 2021 program -- an increase of 74% over the 5-year period. However, the value of VICSWIM must not be judged on numbers alone.

The post-program survey, sent to all parents and guardians, received 1,384 responses. This annual survey provides the opportunity for parents to not only evaluate the program but to provide feedback and ideas which will inform opportunities for improvement to VICSWIM into the future.

The 2021 VICSWIM program scored an incredibly high Net Promoter Score of 65.17% (up from 56.08% in 2020) and a program satisfaction rating of 8.43 out of 10 (up from 8.1 in 2020). To further re-enforce the public demand for VICSWIM, 88% of parents surveyed indicated they were likely or highly likely to enrol their children in the 2022 program. Furthermore, 97% believed there was scope to grow the program in their community if additional classes were made available.

Regional Co-ordinators

VICSWIM is driven by the tireless efforts of our 23 Regional Co-ordinators. The passion and dedication shown by our Regional Co-ordinators toward VICSWIM is inspiring and without their commitment we would not be able to deliver VICSWIM in so many venues, safely and to such a high level of quality parental satisfaction.

Regional coordinators undertake the risk assessment of each venue, drive the recruitment of swim teachers from their communities and co-ordinate and manage the myriad of issues which arise

throughout the program. For 2021, with the addition of new Inland Waterway venues, a dedicated Inland Waterway Regional Coordinator was appointed.

The VICSWIM program has never been more important to Victorians

The VICSWIM program fills a vital void in the states learn to swim offering, providing intensive swimming lessons at a variety of venues and in communities who would otherwise not have access to swimming lessons.

Of the 1,384 participant surveys, 787 or 56.86% indicated that VICSWIM was the only swimming lessons their child/children had participated throughout the previous twelve months. For many living in rural and regional locations, VICSWIM often provides the only swimming lessons their community has access to each year, further contributing to the liveability, safety and quality of those communities.

The Life Saving Victoria, Drowning Report 2019/20 identified that in the 2019/2020 financial year, 248¹ people drowned in Australian waterways with 34² of those drowning in Victoria.

The Drowning Report 2019/20 also identified:

- Apart from drowning deaths a further 100 people experienced a non fatal drowning incident
- At least 21% of drowning deaths in 2019/20 were of people from culturally and linguistically diverse (CALD) communities
- 50% of all drowning deaths were a result of unintentional water entry
- Drowning in inland and coastal waterways continues to increase, with 35% and 34% of incidents occurring in these locations respectively in 2019/203

Life Saving Victoria, in their 2019/20 Drowning Report identified that of the 11 Primary areas and goals of the Victorian Water Safety Strategy 2012-2020, five were rated as "urgent work needed" including three areas VICSWIM specifically seeks to address, being:

Reduce drowning in high risk

- populations (includes Aboriginal and Torres Straight Islanders, people from culturally and linguistically diverse (CALD) backgrounds.
- Reduce downing in coastal waterways
- Reduce drowning in inland waterways

Since July 2020, an additional 42 drownings have occurred in Victoria as reported in the Herald Sun on Sunday, 31 January 2021. The VICSWIM program is a dedicated and important drowning prevention program and the continuation of the program will be critical to enable the achievement of the Victorian Government's Water Safety Strategy goals.

Building our knowledge and capacity to deliver in high risk locations

In direct response to the need to address the disproportionate number of drowning fatalities occurring in coastal and inland waterways Aquatic Recreation Victoria consciously sought to increase its capacity to increase the number of locations and classes being offered in these higher risk locations.

As part of building the open water and inland water capacity of the program for the first time all swim teachers teaching at inland waterways were required to complete the Life Saving Victoria's Inland Waterway Certificate. Two new inland water way venues were added to this year's program, Lake Nagambie and Cohuna (Apex Park) and their value was immediately appreciated by their communities with "Robyn" posting on the Nagambie Community Notice Board Facebook page:

"Just wanted to say thank you to VICSWIM and Strathbogie Shire for the opportunity to enrol my children in the VICSWIM "Lake Nagambie" swimming lessons this week. An invaluable opportunity I would recommend to all parents to enrol and participate in the future"

Life Saving Victoria life guards

VICSWIM's approach to the implementation of the program in



open water coastal venues requires the VICSWIM program, where possible, to operate between the flags at LSV patrolled beaches. A new risk management and safety initiative for the 2021 VICSWIM program was to provide additional, program specific life guards at Altona Beach, the two Torquay beaches and Ocean Grove which complimented the LSV life guards already patrolling the venues.

The programs risk management strategies were strengthened in 2021 to ensure that all coastal venues must have a minimum of two qualified swim teachers and ensuring at least one teacher at unpatrolled venues held a Bronze Medallion/CSLSC or Inland Waterway Certificate. At coastal venues where the swim teachers did not hold these qualifications a dedicated LSV life guard was engaged.

Risk management

In preparation for VICSWIM 2021, ARV engaged the services of a risk management consultant to develop the VICSWIM Risk Management Framework.

A priority prior to next years VICSWIM program will be to further embed this risk management methodology into the operational procedures of the VICSWIM program, especially reviewing and evolving open water and inland water ways safety standards, protocols and procedures.

Given the continuance of the COVID-19 pandemic with Victoria, ARV developed and implemented Covid safe plans specific for indoor pools, outdoor pools, open water venues and inland waterways. All of which had different safety requirements and different capacity considerations. Several 2021 Vicswim venues required additional cleaning times between classes and additional time for exiting customers. Hand sanitiser, QR code attendance trackers and equipment cleaning materials were sourced and distributed to enable Covid safe venues.

VICSWIM profile across Victoria

In 2021 VICSWIM was run at:

- 27 Metropolitan indoor venues
- 12 Metropolitan outdoor venues
- 12 Regional indoor venues
- 10 Regional outdoor venues
- 3 Inland open waterways
- 13 Open water beach locations

Of the 167 venues, 10 were new to the program, not participating in last years program. While the number of venues has reduced for this year's program we are especially proud that VICSWIM was conducted in 8 of the top 10 and 18 of the top 25 municipalities with the greatest socio-economic disadvantage in Victoria.⁴

Overall, VICSWIM was run in 58 of the 79 Victorian municipalities as well as venues in the Albury City Council. Of the 58 participating municipalities 37 were rural or regional municipalities.

The majority of the 100 regional outdoor venues are located in small communities, which if it were not for the VICSWIM program, would not have access to localised swimming lessons at all throughout the year.

In order to ensure VICSWIM remains as cheap and accessible as possible we will continue to work with venue managers and councils to seek to reduce the number of venues charging an entrance fee to participants and even in some instances their supervising parents or carers. Of our 167 participating venues, 65 or 39% charged a venue entrance fee. In some instances, the venue entrance fee was more than the daily fee of the VICSWIM program.

Given that 3 out of 4 parents responded in the VICSWIM post-program survey that the reason they registered their children in VICSWIM was because of 'the affordability of the swimming lessons', reducing entrance fees will continue to be a very important area of future focus.

Victorians need access to lowcost swimming lessons

VICSWIM is a low-cost program. Each VICSWIM registration costs \$30 and provides participants with 5 x 30-minute lessons delivered across 5 consecutive days in a week. Due to the additional costs required to deliver VICSWIM in a COVID safe manner a \$5 booking fee was also charged per transaction.

The intensive nature of the program develops each child's water safety awareness, respect for different water environments and of course, their swimming and survival skills.

VICSWIM's low cost is vital for ensuring formal swimming lessons are accessible, especially to families who could not otherwise afford the cost of commercial learn to swim programs.

Future initiatives

Given, that VICSWIM registrations have grown nearly 80% over the last six years, in spite of major obstacles such as major bushfires across Victoria last year and the Coronavirus pandemic this year, the program is well positioned to grow rapidly in both registrations and locations over the next 5 years.

Each year initiatives are introduced to enable improvement of the capacity and efficiency of the program, ensuring the VICSWIM program remains cost effective and accessible for all Victorians.

This year administrative productivity improvements were driven through the integration of payroll and HR systems along with the support of our new accounting partner, Sports Accounting Australia.

Significant investment is also needed to develop additional resources for the induction, training, development and most importantly retention of swim teachers.

Thank you to the Victoria State Government

The VICSWIM program was established in 1976 and we are incredibly proud that the program remains as relevant and as vital in the Victorian Government's "Victorian Water Safety Strategy" and its "Active Victoria Strategy" today, as it was a generation ago.

On behalf of the ARV Board of Directors, I would like to thank the Victorian State Government, Sports Minister, the Minister for Community Sport and the Department of Sport and Recreation, for their support and funding of the VICSWIM program over the last three years. Without this financial support it simply would not be possible to deliver VICSWIM in a way that has become so accessible, loved, trusted and relied upon by the Victorian community to teach vital water safety and survival skills.

VICSWIM evaluation

To be able to measure the true impact of VICSWIM, ARV has partnered with Sport and Recreation Victoria and Deakin University to develop a program evaluation methodology and framework for the VICSWIM program. This is a valued addition to the VICSWIM program and it will assist to assess the effectiveness of the program (short and long term), contribute to evidence base and best practice and will support application for new and continued funding.

Activities conducted to support the evaluation of the 2021 program included:

- Parent & child pre-program interviews
- Introduction of an e-certificate
- Additional questions added to preand post-parent surveys
- Introduction of child participant post program surveys

Future VICSWIM funding

The 2021 VICSWIM Summer Kidz Program was the final program within the 2018-2021 Victorian Government/ARV funding agreement. ARV looks forward to continuing and finalising our future VICSWIM funding discussions and we very much look forward to extending our partnership with the Victoria State Government.

2021 VICSWIM Statistics

Program Participation

Table 1.1 and Figure 1.2 below illustrates that participation in the VICSWIM 2021 program has grown by 3.6% from the previous year and 74% in the last 5 years.

Table 1.3 and Figure 1.4 show that despite the maximum capacity of the program decreasing from 19,998 available places in 2021 to 18,712 in 2020, the total number of enrolments increased by 556. The occupancy rate of the program therefore jumped from 77.93% in 2020 to 86.26% in 2021.

With the continued development of a formal VICSWIM growth strategy and establishment of strategic partnerships it is anticipated that there are strong growth opportunities for growing VICSWIM for many years to come.

To maximise the VICSWIM growth opportunities, it is vital that investment in marketing, technology, and swim teacher induction and training is increased significantly.



Participation by week and skill level

Table 2.1 and Figure 2.2 illustrate the spread of skill level and enrolments across the three weeks.

Week 1, (34% of enrolments) and Week 2, (40% of enrolments) were the program's busiest weeks with classes at their highest capacity. Week 3 only had 26% of enrolments, a further 2% decrease from last year's rate of 28%.

Week 3 typically has less participating venues as many of the private learn to swim operators recommence their swimming lessons for the year in this week and therefore don't host VICSWIM in this week.

Skill Levels B, C and D were the most popular, accounting for 59.8% of total enrolments. The remaining levels A, E, F and G, accounted for 40.2% of remaining enrolments.

VICSWIM 2021 is the same as last year where B, C and D were also the most popular levels.




Venues and participation

Table 4.1 lists each participating venue, their municipality, their location (metropolitan or regional), type of venue, whether an entry-fee was charged, whether it was their first year hosting the program, whether they provided their own staff and the number of enrolments at each venue.

The five venues with the highest enrolments are as follows:

- 1. 711 Ocean Grove (Regional, Open Water)
- 2. 686 Torquay Cosy Corner (Regional, Open Water)
- 3. 583 Ivanhoe Aquatic Centre (Metropolitan, Indoor Pool)
- 4. 393 Diamond Creek Outdoor Pool (Metropolitan, Outdoor Pool)
- 5. 368 Kardinia Aquatic Centre (Regional, Outdoor Pool)

Just as important as having venues with large numbers of children experiencing swimming lessons, VICSWIM was conducted at 37 venues with 20 registrations or less. All but one of these smaller venues were regionally located.



Participating local councils

Tables 6.1 lists the 22 (out of 31) metropolitan municipalities, which participated in VICSWIM while Table 6.2 lists the 36 (out of 48) rural and regional municipalities which hosted at least one VICSWIM venue.

VICSWIM was hosted in 73% of Victoria's 79 municipalities.

Albury City Council also participated in VICSWIM 2021.

Table 6.1 and 6.2 also identifies the Victorian municipalities and the number of VICSWIM venues hosted by each municipality in 2021.

Index of Relative Socio-economic Advantage and Disadvantage

The Australian Bureau of Statistics calculates a rating system titled the "Index of relative socio-economic advantage and disadvantage" (IRSAD). The rating system summarises information about the economic and social conditions of people and households within an area, including both relative advantage and disadvantage measures. A low score indicates relatively greater disadvantage, whereas a high score indicates a higher general advantage.

VICSWIM 2021 was hosted in 8 of the top 10 and 14 of the top 20 ranked municipalities of greatest disadvantage.





Of the 21 municipalities not hosting the VICSWIM program in 2021, 9 are ranked in the top 25 municipalities with the least social and economic disadvantage, that is, Victoria's most affluent municipalities.

VICSWIM marketing and promotions

The VICSWIM 2021 marketing and promotion strategy was again predominately a social media and email marketing campaign to our growing databases of participants and their families.

To compliment the digital and email marketing strategy, posters and flyers were distributed to a number of our venues and primary schools in or near a VICSWIM location. Additionally, joining/posting to the Facebook community groups of townships, councils and schools in VICSWIM locations to raise awareness of the program and boost enrolments in those areas.

VICSWIM's Facebook audience grew to 7,487 likes (up from 7,214 in 2020) and the widest-reaching post this year reached 21,284 people and was engaged with 3,009 times

VICSWIM's Instagram following grew to 743 followers (up from 679 in 2020) and a total of 64 Instagram stories were shared across the 3 weeks, often reposting content shared by VICSWIM parents.

A document package with images, text and marketing collateral was circulated to venues to encourage them to promote VICSWIM on their social media channels. From implementing this, we saw a rise in online engagement with parents asking questions about the program and wanting to get involved.

In previous years, significant marketing and promotion has been undertaken in the weeks leading up to VICSWIM's opening day (the day on which enrolments open) and the beginning of the VICSWIM program. Unfortunately, in 2021 much of the planned marketing activity was not undertaken due to the large levels of uncertainty caused by the Coronavirus pandemic.

Despite a relatively subdued marketing campaign, this did not dampen the enthusiasm from families to enrol in the program.

Opening day, which took place on the 23rd of November 2020, saw 10,066 enrolments occur within the first 24 hours. This is an increase of 2,438 enrolments from the previous first day of enrolments in 2019, which was 7,628.

Newspaper Coverage

The 2021 VICSWIM Summer Kidz Program was featured by several media outlets across Victoria which helped to raise the already-strong profile of this vital water safety program.

Regional newspaper coverage included articles in the Bendigo Advertiser, Wangaratta Chronicle, Mildura Weekly, Sunraysia Daily, Phillip Island and San Remo Advertiser and Hamilton Spectator, in which the importance of accessible and lost-cost water safety lessons was highlighted.

Deb Gordios, VICSWIM's Inland Open Waterway Coordinator, was interviewed on WIN News Bendigo to discuss and promote the benefits of VICSWIM's Inland Open Water program at Crusoe Reservoir, Gunbower Creek and Lake Nagambie. ARV CEO Kathy Parton was also featured in a WIN News Western Victoria story about swmming lessons post-pandemic.

Most notably, Aquatics & Recreation CEO Kathy Parton and the 2021 VICSWIM Summer Kidz Program were featured in a two-page feature article in the Herald Sun on Sunday, 31 st January. This article brought Victoria's tragic drowning statistics into sharp focus and profiled VICSWIM as a key State Government-funded initiative to reduce the drowning rate and build confidence in children's aquatic abilities moving forward.

Promotion of the VICSWIM program through media outlets is highly valued as it enables increased reach, awareness and promotion of the program.

2021 New Initiatives

VICSWIM Evaluation

In 2021 ARV partnered with Deakin University and the Victorian Department of Sport and Recreation to undertake an evaluation of the VICSWIM Program, The evaluation consisted of three phases:

- A quantitative study that examined the experiences of Victorian parents and their children who participated in VICSWIM in 2021, regarding the impact of VICSWIM on children and their families, ie children's swimming levels, water safety, survival skills and swimming knowledge.
- 2. Development of an evaluation framework for VICSWIM to use into the future
- 3. A quantitative evaluation of the VICSWIM program over 2020/21 using the new program.

Risk Management Framework

In 2021, ARV partnered with Risk Intelligence to review and enhance ARV's risk management documentation to ensure it is fit for purpose, and meets industry best practice. The enhanced resources were used by volunteers and employed personnel undertaking duties at the various statewide aquatic locations where VICSWIM was conducted.


COVID Safe Planning
