



There is no question that the 2020/21 year has been an extraordinary year for the Victorian Aquatics and Recreation Industry as we all responded and adapted to the new COVID-19 normal.

Our purpose has never been more relevant than over the past year as we supported our members impacted by the COVID-19 pandemic.

Throughout 2020/21 we have continued to listen, coordinate, engage with our members and partners and provide services to meet your needs whilst responding to the challenges presented.

Great work has again been achieved by the ARV standing committees, sub committees and other ARV led industry groups to foster important conversations, collaboration and consultation as part of our Peak body leadership.

This engagement has ensured ARV has been aware of the contemporary issues experienced by our industry over this year and has enabled and informed the ARV 2020/21 advocacy strategy. As a priority ARV have advocated on behalf of the Industry to the Victorian Government to ensure the safe, viable reopening of the industry following multiple closures of our industry as well as advocacy to ensure the sustainability of the industry.

ARV have successfully continued to provide important services, programs and activities through this unprecedented year. A number of key events and activities included a successful Vicswim summer Kidz program in January 2021 which provided the opportunity for 16,516 enrollees young Victorians to learn water safety and survival skills in 167 both indoor, open and inland natural water venues. This was an outstanding outcome given the reduced capacity of the program and the fact that 375 enrolments were refunded due to the Coronavirus quarantine restrictions, testing and the provision of medical certificates.

Sincere thanks to the Victorian Government for their commitment to an additional two years of investment in 2022 and 2023 for the annual VICSWIM program that has now been provided in Victoria for 45 years.

Another successful event was the ARV Regional Industry conference in May 2021 attracting 245 industry representatives to the Warragal community Arts Centre.

On behalf of the ARV board, I take this opportunity to acknowledge and thank the ARV team CEO Kathy Parton and Taya Phillips – Member Services and Events Coordinator and their teams members and contributors who have enabled delivery of all ARV activities. Throughout this challenging year the ARV team have operated with resilience, care, great skill and capability to ensure delivery of highly valued Industry services.

Thank you to the ARV board members Alexia Morgan, Ben Tudhope, Ray Smith, Paige Buse, David Le Page for their continued contributions. You have all both enabled the provision of industry insight and expertise and good governance to enable a successful year for ARV.

If there is one thing that 2020/21 has taught us it is the importance of being able to quickly meet the changing needs of our members and partners. We are grateful for the ongoing trust and confidence we have received from our various Industry stakeholders and partners enabling us to foster our vision to be your voice for the Aquatics and recreation industry.





Throughout the 2020/2021 ARV have continued to lead industry engagement and advocacy activities to ensure the needs and issues within our industry were represented to the Victorian and Federal Governments.

As the peak Victorian Aquatics and Recreation industry body, ARV was sought upon by the Victorian Government for industry advice and information.

Key areas of advocacy have included:


Outcomes from this advocacy have included increased funding and temporary EFT for ARV and the Industry, change to Victorian Government COVID directions for our industry and a range of advocacy activities are ongoing. It is expected that advocacy activities will continue into the 2021/2022 year.

Industry Reopening(s)

Road map and COVID-19 directions amendments including density requirements, exemptions etc.

Recommendations for change regarding reopeneing COVID restrictions

Aquatics Workforce Support Package

Issues experienced within industry individuals, teams and organisations. ARV recommended support for the industry.







Working for Victoria Initiative

The Working for Victoria initiative is part of the Victorian Government's \$1.7 billion Economic Survival Package. This initiative aims to help businesses and people who have lost their jobs during the COVID-19 pandemic. The Working for Victoria Fund is designed to connect workers with new opportunities that will help our community and contribute to Victoria's ability to respond to the pandemic.

In 2021, the Victorian Government supported the introduction of the Working for Victoria Initiative into the Victorian Aquatics and Recreation industry. This initiative has enabled the temporary employment of seven EFT across our industry to deliver a range of key Industry projects that have emerged following the introduction of the COVID-19. The projects identified will assist the industry in:

- Recovery from impacts of the COVID-19 pandemic.
- Minimising future impacts of COVID-19 on the industry.
- The health and wellbeing recovery of the Victorian community.

Jobs Victoria and DPJR partnered with ARV to enable the leadership and coordination of this initiative within the Victorian Aquatic and recreation industry. 7 temporary EFT were employed within ARV, Belgravia Leisure, Aligned Leisure, YMCA, Clublinks and Blue fit to develop and deliver key industry projects including:

- Digital content and analytics resources,
- Victorian Aquatic's and recreation industry profile,
- Contract Management Framework industry resource and education program,
- Industry Access and Inclusion Framework,
- · Industry Workforce Retention and Attraction strategies,
- · Industry awareness campaign and communications resources,
- COVID Safe Management Practice resources,
- Environmental sustainability industry framework resource.





Play It Safe By The Water



Established in 1998, Play It Safe by the Water is a public education and awareness program that aims to increase safety around water and reduce the number of drowning incidents in Victoria. The program also alerts Victorians to the risk associated with recreational play and swimming in coastal and inland waterways.

The Victorian Government initiative is a collective of 20 aquatic agencies working within the aquatics and safety sectors in promoting positive change in relation to water safety, through education, events and awareness activities to ensure water safety is a priority for all ages, genders and cultures.

Through the state government initiative ARV provided the annual delivery of Play It Safe By The Water promotional merchandise to 200 aquatic facilities across Victoria in an effort to continue the strong message of playing it safe by the water.

Victorian Public Pools -State of Sector Report



ARV are working with LSV to develop the annual Victorian Public Pools – State of the Sector Report provides a snapshot of the public pool industry in the 2020/21 year.

The public pool industry comprises facilities including council-owned aquatic facilities, learn-to-swim centres, early childhood care, and tertiary education and higher education venue pools.

Any pool or facility that conducts swimming lessons is considered public for the duration of the lesson/s, as is any swimming pool or facility that offers access on a pay-per-usage basis for the duration of such activities.

The target audience for the State of the Sector Report includes aquatic facility owners and operators, aquatic industry agencies and government departments.

This report provides:

- An overview of the industry's size, scope and value.
- Insight into customer usage trends and patterns.
- Analysis of industry safety performance.
- An overview of sector initiatives and research projects.
- Details of key industry award winners.
- Information on the impacts of COVID-19.

It is expected this important industry resource will be published and distributed in December 2021.

Water Quality Risk Management Plan Guide

In 2020 ARV in partnership with the Department of Health and Human Services and Roejen Services developed a Water quality risk management guide and template to assist aquatic facility operators develop an aquatic facility water quality risk management plan. The guide outlines the minimum requirements for an aquatic facility water quality risk management plan and how the plan can be tailored to suit each specific aquatic facility. The guide should be used alongside the Water quality risk management plan template and is also supported by the guidelines which detail how to manage water quality within an aquatic facility. A water quality risk management plan details how aquatic facilities will comply with the aquatic facilities provisions of the Public Health and Wellbeing Regulations 2019 and the Water quality guidelines for public aquatic facilities – managing public health risks (the guidelines).





Advancing Women in Aquatics and Recreation

ARV and the director of Advancing Women in Sport & Business, Michelle Redfern partnered together to facilitate a series of online monthly workshops across a 6-month period. Each workshop provided a combination of facilitated learning, structured networking and practical pragmatic leadership, business and commercial skills development for women.

The Advancing Women in Aquatics and Recreation provided a thought-provoking experience to challenge my career focus and approach. ActiveXchange Seminar

As part of ARV's Partnership with ActiveXchange, ARV hosted members for an information session on ActiveXchange and the power of a connected network. Used by hundreds of venues each week, and having now delivered in excess of 170 Investment Planning Reports across Australia and New Zealand, SportsEye supports leisure, sport and government by making data simple to use by creating insights that shape operational, planning and marketing decisions to increase activity and membership of sports and venues with its partners. In addition, SportsEye helps the partners better connect with local government and funding stakeholders by using its community health and wellbeing and Social Value insights.

James Ellender, CEO ActiveXchange was joined by a range of Victorian based partners already using ActiveXchange to provide ARV members a better understanding of the power of the connected network and how venues, planners, administrators, and program specialists are using the various tools to help plan, govern, advocate and grow in Sport and Leisure.





For many years The Australian Leisure Facilities Association (ALFA) provided information sharing, networking, collaboration and project support for the state bodies and produce advocacy opportunities at a national level. individual state associations to operate ALFA.

In 2019 ALFA determined to cease its operation as an Incorporated Association and transition into a networking Committee.

In 2020/21 ARV led the establishment of the Aquatic Recreation Network Australia (ARNA) to ensure continuation of a national network aimed at providing information sharing, networking, collaboration between state peak associations and representatives and deliver Aquatic and Recreation Industry project support and advocacy at a national level. The ARNA networking committee meets bimonthly and over this challenging year has provided an opportunity:

- To provide a forum for cooperation between State Peak Associations and representatives involved in the industry in Australia;
- To discuss and advocate on behalf of the National Aquatic and Recreation Industry for positive change to on the national stage;
- To provide input and advice on issues related to Aquatics and Recreation Industry to Government departments and relevant Australian Aquatics and Recreation Industry committees to enhance the National Aquatics and Recreation Industry;
- To identify funding sources and opportunities available for advancing the Australian Aquatics and Recreation Industry;
- To deliver national projects/initiatives that provide benefits to state bodies as determined e.g.
 - ALFA national awards
 - ALFA national state of the sector report
 - Benchmarking
 - National study tours
 - Mentor project
 - Digital/online national seminars and workshops
 - Leadership Program Advancing Women in the Aquatic & Leisure Industry

ARV Committees and Industry Groups

ARV have continued to chair a range of Industry representative committees and networks to ensure a space for Industry discussions and response to the Covid-19 challenges aswell as enabling contemporary Industry experience, knowledge and information has informed this advocacy including the Victorian Aquatics and Recreation industry Leaders groups (VARILG), ARV committees, and the National committee ARNA as well as participating in a range of Victorian and national Committees including the National Aquatic Industry Council, Victorian Aquatics and Industry Alliance (VAIA),

It is expected that many of these Victorian and National committees will continue into the 2021/2022 year as the COVID-19 pandemic continues to impact the Aquatic and recreation industry.

These committees are designed for ARV and the wider industry to collaborate and key industry trends and challenges. Attendees can contribute and discuss ARV projects and activities, and collectively problem solving and provide feedback for our industry.

Throughout 2020-21, these committees have been active either undertaking meetings or working on key ARV Projects during online technology such as Zoom.

Thank you to all who have been involved and assisted with our committees throughout the last 12 months. Create strategic opportunities – focused time to get out of your business and grow your knowledge to adapt to industry changes, threats and emerging opportunities.

Staying relevant and competitive – COVID-19 has shown everyone how fragile the aquatic and leisure sector is when confronted with pandemics or business disruptions. Being well connected and unified builds resilience and the capacity of the group to pivot quickly.

Provide mental health support – these challenging times have tested teams to breaking point with many staff leaving the sector. Having colleagues to provide support, advice and mentoring is an important element of not being isolated when confronting similar business or team culture challenges.

Participate in regular catch-ups – the group will meet quarterly via video conference and where possible face to face twice per year to stay connected and engaged with the Strategic Plan

ARV National Industry Leaders Group

This committee includes national representation from all management companies and industry consultants.

The purpose of the National Industry leaders' group is to:

- Provide information sharing, networking, collaboration and enhanced integration between key Victorian Aquatic and recreation representatives
- Support National Industry engagement, coordination and advocacy
- Stronger alignment and roles between Federal, State and Local Governments

ARV Stadium Networking Committee

A newly-formed committee to service those centres and standalone facilities that incorporate stadiums into their curriculum. This network is open to those who run, manage and support basketball stadiums in addition to health and fitness managers who may use the area and facility for multi-purpose spaces.

ARV Victorian Industry Leaders Group

The Victorian Aquatic and Recreation Industry Leaders Group was established in March 2020 as an alliance of industry bodies for the aquatics, recreation and leisure facilities industry in Victoria following the outbreak of the COVID-19 pandemic. The purpose of this groups establishment was to support Victorian industry engagement, coordination and advocacy following the outbreak of the COVID-19 pandemic. The representation of CEO's from all 5 management companies, SRV, LSV and MAV determined a range of strategic opportunities for focus in 2021. These include:

- Further Advocacy, Industry coordination opportunities
- Enhanced integration between Government departments
- Stronger alignment and roles between Federal, State and Local Governments
- Investment in the development of ongoing evidence base
- Reconfirming/redesigning Victorian Aquatics and Recreation
 Industry

ARV Local Government Contractors Networking Committee

The purpose of this group is to be a Local Government contract support network – sharing stories, learnings, experiences, challenges, data and innovation ideas.

Be a strong voice for management operators – to influence, advocate, lobby and educate.

ARV Traders and Suppliers Networking Committee

A networking committee for all ARV Trade and Supplier members where discussions are held about how to support the Aquatics and Recreation industry and how to better service the industry needs and requirements. The networking committee is also an opportunity for reflection on ARV events and how increased networking amongst trade and delegates can be achieved.



Aquatic Recreation Network Australia

ARNA comprises of the peak bodies of all states in Australia including representatives from Tasmania and Northern Territory.

The purpose of this bi-monthly Networking Committee facilitated by ARV is to provide information sharing, networking and collaboration between state peak associations and representatives and deliver Aquatic and Recreation Industry project support and advocacy at a national level.

Digital Communications

Over the course of 2020/21, ARV has invested in an overhaul of its communications and engagement. This included continued social media presence and greater use of mailing lists.

A significant feature of the digital communications overhaul included implementing a Digital Membership Welcome Kit. This digital journey is a series of seven automated emails, welcoming new ARV members to the organisation. The series of emails covers:

- ARV Services, resources and team
- Key member documents
- Industry events
- Digital engagement opportunities
- Get involved committees and industry groups
- Sponsors and suppliers
- Key contact information

This new digital welcome kit replaces the traditional paper-based welcome pack. The new digital format has allowed ARV to drive traffic to its website and foster relationships with members regardless of restrictions preventing face-to-face member engagement. The new Membership welcome journey has been embraced by ARV members, and assisted in positioning ARV and its brand as the peak body of the Aquatics and Recreation Industry.

ARV has also increased its social media presence by activating it's LinkedIn page, which has quickly become ARV's most engaged with platform. The LinkedIn page saw a 20% growth of followers between December 31 2020 and June 30 2021. ARV has received positive feedback from industry stakeholders regarding increased LinkedIn presence. ARV intends to increase LinkedIn activity as industry events and opportunities grow.

As part of navigating and advocating for the Industry, ARV continued its regular and informative communications to members, passing on key information from State Government in an ever-changing environment. Statements, Restricted Activity Directions (RADs) and announcements were provided directly to ARV members, and shared on ARV Social Media.

Into next year, ARV will continue to grow digital communications strategically, with continued work on Social Media, continually searching for opportunities to grow mailing lists, and focus time into ensuring the ARV website is a hub of information, support and resources for the Industry.

VICSWIM Summer Kidz 2021

VICSWIM Summer Kidz 2021 successfully delivered 80,705 hours of essential water safety education. The program was lucky to be positioned at a time with low COVID19-Restrictions, allowing the program to proceed without any major impacts.

VICSWIM'S 345 staff delivered the program at 167 venues across Victora, with 123 (73.7%) of these located in Regional Victoria.

The 2021 program marked a 72% growth of enrolments in 5 years. This is an exceptional achievement, impacting many thousands of Victorian families, and ultimately saving lives.

VICSWIM parents gave VICSWIM a Program Satisfaction Rating of 8.43, up from 8.1 in 2020. 56.86% of parents indicated this was their child(ren)'s only swimming lessons in the last 12 months. This demonstrates another aspec of the extreme impact of aquatics and recreation facility closures throughout 2020.

The impact of COVID-19 was minimised during the program due to thorough COVIDSafe plans, developed in the months leading up to the program. The COVIDSafe plan was not only in place to protect participants, but also parents and guardians, and VICSWIM Teachers and coordinators. ARV extends thanks to the participating venues and organisations for also upholding an excellent COVIDSafe standard and providing a safe environment for VICSWIM families.


ARV was delighted to connect the VICSWIM program with ARV Members and Partners. Uniting the industry to support the VICSWIM Program is an honour each year. Of VICSWIM's 167 venues, 80 were ARV Members. Thanks to the Belgravia Foundation, Mildura VICSWIM participants were provided with brand-new Zoggs goggles to keep them swimming. Zoggs is also an ARV Member.

In 2021 ARV partnered with Deakin University and the Victorian Department of Sport and Recreation to undertake an evaluation of the VICSWIM Program, The evaluationconsisted of three phases:

- A quantitative study that examined the experiences of Victorian parents and theirchildren who participated in VICSWIM in 2021, regarding the impact of VICSWIMon children and their families, ie children's swimming levels, water safety, survivalskills and swimming knowledge.
- 2. Development of an evaluation framework for VICSWIM to use into the future
- 3. A quantitative evaluation of the VICSWIM program over 2020/21 using the new program.

ARV also partnered with Risk Intelligence to review and enhance ARV's risk management documentation to ensure it is fit for purpose, and meets industry best practice. The enhanced resources were used by volunteers and employed personnel undertaking duties at the various statewide aquatic locations where VICSWIM was conducted

The 2022 VICSWIM Summer Kidz program has again recieved funding from the Victorian State Government Department of Jobs, Precincts and Regions. ARV thanks Ros Spence MP for her continued support of the VICSWIM Program.
